# **How Many Views Do Our Zoom Recordings Get?**

It is often asked how many times people view our Zoom recordings. These are all on YouTube and linked to from our website at <a href="https://www.lwv-kitsap.org/video-recordings/">https://www.lwv-kitsap.org/video-recordings/</a>. To answer the question, I decided to do a bit of homework. According to the YouTube analytics, the year between July 23, 2020 and July 22, 2021 had 1.3K views and 214 hours of viewing. The year between July 23, 2021 and July 22, 2022 had 2.1K views and 444 hours of viewing. Things have almost DOUBLED in the last year!

Our YouTube channel currently has a total of 113 videos and has gotten a total of 3,675

views. Some of the recordings are of our forums but there are just as many, if not more, recordings of our community education programs dealing with housing, mis/dis-information, climate, healthcare, unit meeting guest speakers and more.

Of the 113 recordings, the one getting the most views is the recording of the 2021 Bremerton Mayor General Election forum that has gotten, to date, a total of 372 views.

Why does all of this matter? Prior to COVID it was challenging to get recordings of our events. Each event had to be held at a location that was set up so that BKAT could record it or we had to record it ourselves with our own semi-professional equipment. I can personally testify that recording it ourselves was very time consuming. With Zoom, recordings can happen automatically.

The ease of making Zoom recordings and the extreme increase in the number of viewings of these recordings are points to consider when deciding whether to continue with Zoom after the COVID risks are behind us.

# **Getting to Know Board Member Pat Troxell**



Pat was born in Ohio but at the early age of 3, in the late 1940s, her family relocated to California where her mother worked as a bookkeeper for United Airlines to support the family. It was during her childhood that Pat contracted polio. Prior to a vaccine being developed, polio was a devastating disease that invaded the brain and spinal cord, often causing paralysis. That paralysis affected the patient's ability to breath, which required mechanical intervention. Like many patients, Pat was placed in an iron lung. Through medical intervention and a miracle, Pat survived polio but it left her with severe physical impairment.

As a child, having a disability meant that she didn't have the opportunity to attend grade school like peers in her age group. It wasn't until age 12 that Pat was finally able to attend school. Pat mentioned that the Americans with Disabilities Act was not signed until 1974. Before that, the protections and rights did not exist, which meant schools did not have to accommodate disabled students.

One day, when her father had car trouble, Ken Troxell offered to give him a lift home. Unbeknownst to Pat, Ken had asked for the family's phone number and the next day he called Pat. He had only recently moved to San Diego when they met. They hit it off during that first call and were married three months later. It was just over year later that they welcomed their daughter Mayda.

In 1973, Pat's husband Ken, a machinist, was recruited and accepted a job in Kitsap County at the shipyard. So, the family relocated to Kitsap County where they have remained, other than a 6-month period when they lived in Panama while Ken worked as a machinist/engineer at the Panama Canal — this was all about adventure! Pat lost her husband to a brain aneurysm 1983. At the time her daughter was only 13.

Pat held a variety of positions during her working years but spent 10 years working as a computer systems analyst, writing programs in Keyport until early retirement. She decided to get her master's in social work. She attended the University of Washington, where she lived on campus and thoroughly enjoyed the experience. Having had to work early on, going back to school later gave her the opportunity to experience some of the things she felt she'd missed earlier in life.

After obtaining her master's, Pat pursued a career in social work — her own experiences made her an effective advocate for the disabled. Her perspective and experience helped when she worked as a lobbyist and advocate for the disabled, for a period of time, including serving on the Governor's Committee.

Over the years, Pat has admired the work and forums done by the League, so she decided to join about three years ago. Besides League, Pat enjoys reading and closely follows politics. She also enjoys family and is fortunate to have daughter Meyda living nearby in Port Orchard. Mayda and her husband, married for 35 years, have two grown children. Pat's granddaughter and husband live out of state and they have two children with another on the way in October. Her grandson lives nearby and is in a serious relationship.

## **Forums Committee**

The Forums committee is taking a short break before starting to organize the October forums for the upcoming general election on Nov. 8. We anticipate hosting quite a few, but we won't know the exact number until the end of the candidate filing period. The two primary forums we hosted last month went very smoothly. These were for the State Representative, 23rd Legislative District and the Kitsap County Commissioner, District 3. There were 42 attendees for the State Representative forum and 76 attendees for the Commissioners forum.

Last year we had four primary forums which included the Port Orchard City Council (28 attendees), Bremerton City Council (69 attendees), Bainbridge Island City Council (111 attendees), and Central Kitsap School Board (20 attendees). It appears there has been a slight increase this year in the number of attendees.

We have also posted on our website the US Representative, Congressional District 6 forum
