## **Paying Attention to Accessibility**

When Planning Internal League Programs
Ann Pyles with Pat Troxell

As a member of the Diversity, Equity & Inclusion Committee of the LWV-Kitsap, I volunteered to interview League member Pat Troxell. We wanted to alert League members about the importance of paying attention to Accessibility when planning internal and external League programs. To practice inclusion in our lives, our communities, and the organizations we belong to, we need to assure that those with mobility issues, health challenges or special needs can engage in our programs. Pat's lifetime of experience gives us a unique perspective on accessibility.

Pat has used a wheelchair since she was five-years-old due to contracting Polio. She has experienced many problems with efficient and affordable public and private transportation services in Kitsap and is very interested in this topic. After her husband's unexpected death, she realized she needed to finish her college education to support her daughter, 13, and her nephew, 8, for whom she had custody. Pat then experienced being discriminated against in educational opportunities, which resulted in her filing a complaint, which rectified the situation.

This education enabled Pat to win a co-op position at the Naval Base at Keyport (at that time it was called NUWES). In this position, she worked her way up to a GS 11 Computer Programmer System Analyst. At Keyport, she worked as the Chair of the Advisory Committee for Employees with Disabilities. This position helped her develop the Equal Employee Opportunity (EEO) policy and programs for employees with disabilities for their workforce.

After working many years at Keyport and after her kids were raised, she earned her master's degree at the UW School of Social Work. That is where she learned more about government policy when she interned at the King County Office of Civil Rights and Compliance in the Americans with Disabilities (ADA) Office. This experience inspired her to pursue working on WA State policy on people with disabilities, so she moved to Olympia where she volunteered with the Governor's Committee on Employment of People with Disabilities. After a year in Olympia, Pat returned to Kitsap, taught a quarter at a WWU satellite office and worked as a hospital social worker. She has also done Accessibility Audits for Target and others.

For Ann, "I think about this topic quite often because we have an adult child who uses a wheelchair and has other health challenges. Below are a few areas that Pat and I explored and wanted to highlight for our League members to pay particular attention to when planning a program, event or in their personal lives."

Kitsap Access is a shared ride service for people with disabilities who qualify for it, to transport people to most of Kitsap locations and arrange connection to transportation services in other counties. Paratransit service in Kitsap County is for medical purposes. Both agencies are in compliance with the Americans with Disabilities Act. Many individuals who use mobility devices or can't use the lift on the routed bus system, or their destination is not near a routed bus-stop can pay a modest fee to be transported. There is a registration process required and the days/hours of availability vary greatly depending upon where you live in the county and where you want to go. There is no service on Sundays. When planning an event can your members or the individuals you want to attend get to your event? I have talked to Access and they suggest calling them to see if they can provide transportation to this event on your chosen date and time. Is your in-person event located in a place that has an accessible entrance and elevators if needed? Are the doors light enough to open, open automatically or have buttons at reachable levels for a person in a wheelchair? Is there accessible handicapped parking for cars or mobility vans with cleared ramps up to the sidewalk that are not too sharply angled. Always remember to leave ample access on both sides of a mobility van for access by a person using a mobility device. Leave a minimum of 8 feet open on the passenger side of a mobility van with a side access ramp and never park blocking an access cutout to the sidewalk.

There are a few individuals that have their own mobility vans. But they can no longer drive them nor have family or caregivers who can drive them. One idea is to have a cadre of drivers available to use their own vans or other individuals with access to a mobility van and the training to fasten the required tie-downs, to drive those that need this service to our events.

If your program is on Zoom, always set up the meeting with the ability to engage closed captions by those with hearing challenges and/or if there is a lot of background noise in the meeting room. The most accurate closed caption translations seem to take place if the speaker is using a good quality microphone and there is little capture of meeting room background noise. Encouraging members to learn sign language or recruiting members who can translate sign language to do so at meetings. Pat mentioned the fact that even though she has been permanently disabled since she was a child, she still needs to renew her Disabled Parking Placard, for a fee, every 5 years even for her van with a permanent Disabled Person license plate, as well as the tag. This is an extra burden. Maybe this is something the LWV could help remedy.



## Member Spotlight: Barb Willock

Barb Willock and her husband, George, moved to Southworth in 1978. George is a Kitsap native and his parents lived in Manchester, so for him it was returning to his roots. Before their move to Kitsap, they had resided in the Northgate area since their marriage.

Barb learned about the League from friend, coworker and neighbor, Ann Strosnider. At that time, Ann was the editor of the Voter. Both Ann and Barb had worked for the Kitsap Sun newspaper. Barb was employed by the Sun as a page designer and copy editor. When Barb retired in 2011, Ann encouraged her to join the League and become part of the Voter team. She liked that the League took a nonpartisan stance and loved the League's mission to educate the public on issues. Barb has remained active in the League and continues to be a valuable contributor and voice on the LWVK's Voter.

Although not a Pacific Northwest native, Barb grew up in the Seattle area. She describes her parents as conservative. During a discussion with her mother, she learned that her mother had never voted because she "didn't want to cancel her husband's vote." Barb's 20-year career in the newsroom precluded her from being actively involved in politics, but it was something she was interested in and looked forward to being able to participate in one day.

Before her career in media, Barb worked as clerical support for a stock brokerage house and other firms before beginning college. She was 33 when she enrolled in college and studied fiber arts at the University of Washington, eventually earning a master's degree in weaving. Having creative talent, it is easy to see how those skills were so beneficial in her career in media and on the Voter!

Barb and her husband have been married for almost 50 years, their "kids" have been the four-legged variety, most recent being Miniature Schnauzers, but it's been a few years since their last pet. As an avid reader, Barb belonged in a coed book group with her husband for more than 25 years. She now is a member of a woman's reading group, which has been going for about 20 years. Barb loves cooking and knitting. She recently parted with her large loom and focuses most of her attention on knitting these days.

In the coming year, Barb plans to hone new skills with the online Voter format. After using the InDesign program for many years, she's now busy learning the new online tools. She remarked that it's not as easy learning new things but she intends to persevere!

We are planning our January webinar, which is the last scheduled one in our series, Voices from Kitsap County. This one is on the Indigenous Community.

Did you know that we have two Indigenous tribes in Kitsap County (the Suquamish and Port Gamble S'klallam tribes)? Did you know that they are sovereign nations? What exactly does this mean? How do sovereign nations within the United States function - with the federal government, the state government, and the county government? Some of these questions can be answered by the Port Madison Dialogues, which was put on in collaboration between the county commissioners and the Suquamish Tribe.
