# **Kitsap County 2044 Comprehensive Plan**

In May, when Eric Baker joined the League webinar, 2024 Kitsap County Comprehensive Plan Balancing Community Priorities, to give an overview of Kitsap County's Comprehensive Plan, he offered to arrange a meeting with county experts if we wanted to go deeper into any aspect of the plan. We decided to take him up on his offer and are working with county officials for a public program about the county's Critical Area Ordinances (CAO) proposals.

All cities and counties in Washington are required to adopt regulations protecting "critical areas in order to preserve the natural environment, wildlife habitats, and sources of fresh drinking water" (The Growth Management Act (GMA)). These areas include Fish & Wildlife Conservation Areas, Wetlands, Frequently Flooded Areas, Geologically Hazardous Areas, and Critical Aquifer Recharge Areas, so this is obviously a very complex issue.

We hope, through this program, to learn the basics of CAO establishment and what changes are being considered. It is important that we understand the issues and get these regulations right. Our informed comments will influence what these regulations look like.

League member Amy Lawrence will moderate the webinar.
